## 4. First-Aid Measures

### **General advice:**

First aid providers should wear personal protective equipment to prevent exposure. Remove contaminated clothing. Move person to fresh air. ## 6. Accidental release measures

### **Environmental precautions:**

### **Cleanup:**

Dike spillage. Pick up with suitable absorbent material. Place into suitable containers for reuse or disposal in a licensed facility. If application of spilled substance/product is not possible, then spills should be contained, solidified, and placed in suitable containers for disposal. After decontamination, spill area can be washed with water. Collect wash water for approved disposal.

## 7. Handling and Storage

### **Handling**

#### **General advice:**

### **Storage**
